## **SCHEDULE OF PERMIT FEES** – **EFFECTIVE JANUARY 1, 2019**

#### **BUILDING PERMIT FEES**

For all buildings, swimming pools, structures or alterations requiring a building permit, a fee shall be paid as required at the time such permit is issued, in accordance with the following schedule:

Commercial and residential new construction, renovations, alterations or additions where the valuation does not exceed \$26,000.00 the permit fee shall be:	\$75.00
For valuations over \$26,000.00 up to and including \$30,000.00, the permit fee shall be:	\$75.00
Plus, for each additional thousand dollars, or fraction thereof, add:	\$2.50
For the first \$30,000.00, the permit fee shall be	\$85.00
Plus, for each additional thousand dollars or fraction thereof, add	\$4.00
A plan review fee, for commercial construction shall be ½ the permit fee to be submitted with permit applications.	\$75.00
NOTE: Plan review fee is a separate fee from the permit fee and shall not be deducted from the permit fee.	min

- The valuation of a 1 & 2 family dwellings shall be calculated, per every square foot of floor area, based on a value equal to 57% of the current International Code Council building valuation data for residential wood frame construction.
- The square foot rate shall be adjusted based on published changes in the International Code Council building valuations for residential wood frame constructions.
- The valuation of a commercial structure shall be calculated based on the "Square Foot Construction Costs" per ICC Building valuation Data.

## **OTHER PERMIT FEES**

For the moving of any building or structure, other than a portable building the fee shall be:	\$75.00
For the moving of any portable building the fee shall be:	\$50.00
For the demolition of any residential building or structure the fee shall be:	\$50.00
For the issuance of any Certification of Occupancy the fee shall be:	\$40.00
Where any permit has been expired less than 24 months, the reactivation fee shall be:	\$75.00

#### **SIGN PERMIT FEES**

Ground and Monument Signs	\$75.00 / per sign
Billboards	\$200.00 / per face
Temporary signs (15 Days)	\$45.00 / per sign
Portable signs	
1 - 5 signs:	\$75.00 / per sign
6 - 10 signs:	\$50.00 / per sign
11 or more signs:	\$20.00 / per sign

NOTE: Portable Sign permits must be renewed every year.

## **GAS PERMIT FEES**

For the installation, repair, alteration or addition of gas piping, appliances or appurtenances the fee shall be:	\$50.00 / per meter

## **PLUMBING PERMIT FEES**

For the installation, repair, alteration or addition to any plumbing system, fixture or appliance the fee shall be:	\$50.00 / per meter
---	---------------------

#### **ELECTRICAL PERMIT FEES**

For electrical work as prescribed in the Electrical Code of Columbus Georgia, the fee shall be:	\$50.00 / per meter
For temporary electrical service the fee shall be:	\$50.00 / per meter
For construction service permits the fee shall be:	\$50.00 / per meter

#### **MECHANICAL PERMIT FEES**

For the installation, repair, alteration or addition of	
heating, ventilating, duct, air conditioning and	\$50.00 / per unit
refrigeration systems, the fee shall be:	

#### **RE-INSPECTIONS**

Where any work or installation has been disapproved, the fee for re-inspection shall be as follows:

1 <sup>st</sup> Occurrence:	No Charge
Subsequent occurrences:	\$50.00 each

#### **EMERGENCY INSPECTIONS**

Where inspections are required after hours for approved shut downs or other emergency needs, the fee shall be:	\$50.00 for the first hour
Plus each additional hour thereafter:	\$30.00

## **BOARD OF ZONING APPEALS FEES:**

Variance or Administrative Appeal the fee shall be:	\$200.00

#### **SHORT TERM VACATION RENTAL (STVR):**

For a Short Term Vacation Rental Permit:	\$40.00/unit
For Background Check for STVR Permit:	\$20.00/person

NOTE: STVR Permits must be renewed every year.
